## Student Arts Leadership Program

### DESCRIPTION

The ShoreLake Arts **Student Arts Leadership Program** provides a unique opportunity for teens and young adults to work with a local arts non-profit organization supporting youth education. You will work with artists and elementary students in support of spring break and summer camp classroom education, teaching art activities and providing mentorship to younger students.

**Participants can receive between 20 and 140 community service hours, to be determined on a case-by-case basis. This is an unpaid volunteer opportunity.**

### EXPECTATIONS

- Attending the minimum of 5 days (20 hours) of approved service time
- Actively participating in classroom support activities, youth mentorship, and other projects as assigned
- Treating all fellow participants, mentors, and guests respectfully
- Maintaining a positive learning environment
- Adhering to COVID-19 Protocols (see below) and helping to ensure the health and safety of others

### SCHEDULE

Student Art Leaders may serve in the mornings from 8:30 AM - 12:30 PM, or in the afternoons from 12:30 PM - 4:30 PM during half-day camps, and from 8:30 AM - 4:30 PM during full day camps. See the [website](#) for available dates of service. Student Art Leaders do not need to volunteer at every week of camp this summer. However, to provide a consistent experience for our campers, it is our preference that Leaders attend all the days in any given session.

### ELIGIBILITY

To serve as a Student Arts Leader, you must be...

- At least 15 years old
- Either currently enrolled in high school, a G.E.D. program, college, or vocational/technical school, or recently graduated from high school in 2022
- Available to commit to at least 5 days (20 hours) of service
- Up to Date on COVID-19 vaccinations (see COVID-19 Protocols for details)
- Passionate about making art, helping kids learn, and having fun!

### COVID-19 PROTOCOLS

Student Arts Leaders are required to be **up to date** on COVID-19 vaccines for the duration of their service. **Up to date** means a person has received all recommended COVID-19 vaccines, including any booster dose(s) when eligible. ShoreLake Arts will make reasonable accommodation for Student Arts Leaders who demonstrate proof of vaccine exemption.

Student Arts Leaders are also required to wear masks at all times when providing in-person service and maintain physical distance of at least 6 feet from others whenever possible. \*\*Subject to change as conditions improve
